



Safety

Your safety is our priority.

Crow Canyon has formal protocols for responding to emergency situations, both on and off campus. Security cameras are located at the campus entrance and in various indoor and outdoor locations throughout the buildings and grounds. Selected staff members are Certified Emergency Medical Responders, and all staff are instructed in how to respond to nonmedical emergency situations.

Program participants are transported by staff drivers in well-maintained vehicles, including school buses, minibuses, and 16-passenger vans. All our drivers participate in regular vehicle-safety training.

We encourage program participants to explore our beautiful grounds, but recommend that they not hike at dawn or dusk, when wildlife are most active.

Though located in a rural setting, Crow Canyon is also just outside the town of Cortez (population 8,500), where a range of emergency services, including police, fire department, and medical, are available.

Medical Information

Illness or Injury

A Certified Emergency Medical Responder is on duty at all times. In addition, most Crow Canyon staff members hold First Aid cards and can attend to minor injuries. If you should become ill or suffer a serious injury, the Certified Emergency Medical Responder will assess the situation and take appropriate action. For daytime emergencies (7:30 a.m.–10:00 p.m.), go to the front desk of the Gates Building. Overnight (10:00 p.m.–7:30 a.m.), the Certified Emergency Medical Responder is on duty in the First Responder Cabin located adjacent to the other cabins.

Dr. Robert Heyl, a local physician, provides attending-physician coverage for Crow Canyon programs and can be consulted for routine illnesses and injuries. In addition, the campus is located within 10 minutes of Emergency Medical Services (EMS) and a fully equipped hospital with 24-hour emergency room facilities. Off-campus activities (for example, the tour of Mesa Verde National Park) may be conducted in locations considerably farther from medical services. You are responsible for all expenses related to your medical care.

Medical Records

After you register for your program, the sales and enrollment specialist will give you information about creating your personal account on CampDoc.com, where you will enter your health information. CampDoc.com is the leading electronic health record system for camps; the site is secure, encrypted, and password protected. The CampDoc system gives Crow Canyon's medical first responders instant access to your health information as needed. It is our priority to ensure the security, confidentiality, and privacy of your personal health information. Only Crow Canyon's health staff have access to these records.
